SUBJECT: MANUAL OF POLICIES & PROCEDURES (MPP) UPDATE TO

The Department of Child Support Services (DCSS) has adopted the Case Closure regulations into Chapter 1 of Division 13 of Title 22 of the California Code of Regulations on an emergency basis in rulemaking R-2-02-E effective March 25, 2002.
